#### **QUESTION ONE**

Two Members of parliament are on Citizen TV debating on whether the Constitution of Kenya 2010 should be reviewed .Mr Kaluma supports a review and champions for reintroduction of the position of the prime minister .He argues the Kenyan state being multi-cultural nation, it needs the position as a way of strengthening democracy and embedding ethnic inclusivity .Mr Kipchumba opposes this view arguing the new constitution, being the grundnorm , was intended to move Kenya away from an imperial presidency and this has been achieved . Your mum is watching the debate and seeks your views on various issues being canvassed by the two legislators. Proceed to advise her by:

a) Defining and explaining the meaning of the terms **democracy**; **state**; **nation**; **constitution** and **grundnorm**. (10 marks)

- c) Discussing the constitutional evolution of the position of prime minister in Kenya since independence. (10 marks)

# **QUESTION FOUR**

Justice Kubo in his dissent in  $\underline{Dr. Rev. Timothy Njoya and others v A. G}$  (2004) appeared not to abandon the reasoning of the High Court of Kenya in  $\underline{EL Mann} \underline{v R.}$  (1969), where he held that interpretation of the constitution is governed by the same interpretive methodology that applies to interpretation of Statutes (ordinary law).
