QUESTION ONE

'Some Western analysts see Russia's 2022 invasion of Ukraine as the culmination of the Kremlin's growing resentment toward NATO's post-Cold War expansion into the former Soviet sphere of influence. Russian leaders, including Putin, have alleged that the United States and NATO repeatedly violated pledges they made in the early 1990s to not expand the alliance into the former Soviet bloc. They view NATO's enlargement during this tumultuous period for Russia as a humiliating imposition about which they could do little but watch.' (Jonathan Masters October 1, 2022)
