QUESTION ONE

a) Kerubo is a Secondary School teacher who has been married for eight years to Dr. Ongubo and is blessed with two daughters, Abbey and Anney aged 6 and 4. She is constantly abused both mentally and physically by her husband. Her husband has also started consorting with Kwangu, a university student who believes that Ongubo will marry her soon. Ongubo is always drunk, rarely home and does not provide for Kerubo and the children. In addition, due to his philandering, Ongubo has contracted a sexually transmitted disease but refuses to get treatment. Kerubo feels that this marriage is unbearable and wants a divorce. She has come to you for advice. Advise her on whether she can get a Divorce.

Kerubo met Ongubo when they were both in Kisu University. Upon b) graduation, they lived together in a one roomed house in Kisumu Ndogo while job hunting and doing odd jobs. Kerubo got a job first with the Teachers Service Commission and was able to take out a loan and buy a plot of land at Mwembe, Kisii which was registered in her husband's name. Four years later, Ongubo got a lucrative job with the UN and built a palatial home on this land without receiving any help from Kerubo. Abbey and Anney are now both enrolled at an expensive private school. Kerubo is worried about the property that has been acquired in this marriage and whether she has any rights to it. Advise her on her rights to matrimonial property paying special attention to the doctrine of contribution. (10 marks)

c) Advise on the rights of Dr. Ongubo's and Kerubo's Children (10 marks)
