QUESTION TWO

Case scenario: identification (multi-morbidities); Barbara

Presentation Barbara is 42-year-old woman presenting at your surgery for a routine appointment. Three years ago she was diagnosed with early stage (stage

3a) chronic kidney disease associated with hypertension. Her kidney disease and hypertension are managed by a combination of drugs that includes an ACE inhibitor, and dietary restrictions. Barbara is complaining of 'these heads of mine' that she says make her feel poorly, and a discomfort in her back and abdomen.

a) Identify any two comorbidities in Barbara's case. (2 marks)

(b). In view of Barbara's worry and restless movements, suggest the key areas of engagement to the client. In the process of case formulation. (10 marks)

c) Differentiate between psychodynamic and behavioral modalities of case formulations (8 marks)

QUESTION FOUR

Born in Canada. University-educated. There was a parental divorce at age 5. She describes an invalidating childhood, where parents did not acknowledge or praise

her. She experienced sexual abuse and trauma at age 12. She is in a 2-year relationship with a male partner, and there have been recent arguments about the direction of their relationship. She describes a long-standing fear of being abandoned in relationships, and reports having very intense relationships with friends/family. Financially, she is struggling to pay rent and living from paycheque-to-paycheque. Developmentally, there may have been some speech delay. Collateral information from the patient's older brother describe her childhood temperament as being avoidant and fearful of her parents.

- i) Pre-disposing factors (5 marks)
- ii) Precipitating factors (5 marks)
- iii) Perpetuating factors (5 marks)
- iv) Protective factors (5 marks)
