QUESTION ONE

The Republic of Kukurukakara is a country identical to the Republic of Kenya. It has identical laws and an identical system of government. On 17th March 2022, one Prof. Latrick Pumumba, a revolutionary orator, was arrested as he tried to enter the Kukurukakara through the Kukurukakara International Airport. On further inquiry as to why he was prevented from accessing the country, yet he had a valid Kukurukakara passport, he was told that he was deemed to be a threat to national security and thus could not be allowed to enter his mother land. He quickly mobilized his lawyers, who obtained orders directing his immediate release into the country. Despite the court orders, Prof. Pumumba was eventually deported back to the Republic of Bongo, where he is a dual citizen.

News of his deportation caused an upheaval in the Kukurukakara. Umkonto Wesizwe, a militant separationist group immediately started organizing the citizens of Kukurukakara to an active revolt against what it deemed a despotic

government. To calm the tensions in the country, the Republic of Kukurukakara has invited the leaders of Umkonto Wesizwe to a round table discussion.

You are a world renown social justice lawyer. Umkonto Wesizwe has asked you to prepare a memorandum outlining and explaining all social justice issues facing Kukurukakara, for presentation in the meeting. Prepare the memorandum.
