  - i Benson failed to renew his commercial driver's license for five years after it expired. Therefore, he was required to retake the exam to obtain a new license.
  - ii For more than three months after obtaining a new license, Benson

sought a position as a driver. Then he caused an accident in his personal vehicle and was charged with reckless driving. He was convicted of a misdemeanor last June.

- iii Last July, a new statute went into effect. It requires Benson to disclose the traffic conviction to any employer who hires him as a commercial driver.
- iv Benson mistakenly believed the statute did not apply to him. He reasoned that he was not required to disclose the conviction because the vehicle involved in the accident was his personal car, not a commercial vehicle.
- v Benson was hired as a commercial driver last August. Two weeks later, he was fired by his employer and cited by the police for failing to disclose the prior traffic conviction. Benson now challenges the disclosure statute's validity.
